## **NEW BUSINESS:**

### **INCREASE ZONING BOARD MEMBERSHIP:**

Mr. Witkowski stated a request has come from the Zoning Board of Appeals to change the membership to a 5-member board instead of a 3-person board.

Upon discussion the following items were noted:

The LUR allows the Planning Board to recommend the appropriate membership change to the Town Board.

- Due to training received at Corning Community College and advice from the Town Attorney a 5-person membership would allow some flexibility when discussing or visiting a site.
- A realignment of terms will have to be made.
